IN THIS TRAINING, YOU WILL LEARN THE BASICS OF THIS NEW DISCIPLINE IN TWO 2-HOUR SESSIONS. BEFORE, BETWEEN AND AFTER THESE SESSIONS, YOU WILL PRACTICE BY DIVING INTO HANDS-ON EXERCISES. WE WILL FOCUS ON TOPICS AND EXAMPLES THAT ARE RELEVANT FOR AUDITORS.
